

MEMORANDUM OF AGREEMENT

between

Department of the Army and Tennessee Valley Authority

for
Construction, Operation, and Maintenance of
Navigation Facilities on the Tennessee River
and its Tributaries

1. The Tennessee Valley Authority has primary responsibility for budgeting and performing construction work of a capital account nature. In addition to the construction of new locks and channels, this includes additions, retirements, and replacements of existing facilities which qualify as plant changes as defined in the applicable sections of TVA's plant unit catalog.
2. TVA will also be responsible for the maintenance of channels and harbors primarily required for recreational and malaria control purposes, for supply of power for lock operations, and for mapping and preparation of detail reservoir charts.
3. The Department of the Army has primary responsibility for budgeting and performing work of an operational and maintenance nature. This includes operation, maintenance, and repair activities at the locks; additions, removals, and replacements of facilities of a minor nature not qualifying as plant changes under paragraph 1; and maintenance of the main navigation channel and safety harbors together with the channels in connection therewith exclusive of the work described as functions of TVA in paragraph 2.
4. The Department of the Army is responsible for budgeting and performing all work in connection with preparation and revision of "Navigation Charts."
5. When agreed by TVA and the Army to be desirable for the most efficient and economical discharge of these joint responsibilities, (a) TVA may perform maintenance and/or rehabilitation work associated with or incidental to work of a capital account nature, and (b) the Army may perform work of a capital account nature associated with or incidental to work of an operational or maintenance character.
6. TVA and the Army will each year jointly review their respective budgets for the construction and maintenance of navigation facilities on the Tennessee River and its tributaries before the budgets are submitted to the Bureau of the Budget, in order to assure that there will be no duplication of work or requests for funds.
7. If, in the discharge of their respective responsibilities under this agreement, either agency asks the other for assistance in the form of personnel, materials, tools, or equipment, the agency receiving the request shall render such assistance as it may determine to be available. Such requests shall be individually formalized through

correspondence or other forms of authorization for accounting control purposes. The agency making the request shall, upon receipt of properly itemized bills from the other agency, promptly reimburse the other agency for all costs reasonably incurred by it in providing such assistance, including rental value of equipment and the usual allowance for administrative and general expenses.

- 8. In all matters relating to the administration of this agreement and the performance of work thereunder, TVA shall be represented by its Chief Engineer, and the Army shall be represented by the Division Engineer, Ohio River Division, and the District Engineer Nashville District.
- 9. This memorandum agreement supersedes the agreement of July 11, 1946.
